

## **Tackling Undeclared Work in the Western Balkans through Structured Regional Cooperation**

Sarajevo, 15 October 2019

### **Introduction**

Informal economy and undeclared work are important features of the Western Balkan economies and constitute major barriers to enabling inclusive economic prosperity. ESAP-RCC has recently produced diagnostic reports for each Western Balkan economy that look at drivers of undeclared work, the institutional framework and current policy approaches (<https://www.esap.online/pages/11/informal-employment>). Building on current efforts to reduce the informal economy and particularly undeclared work, the reports propose key recommendations on building a holistic strategic approach to tackling informality.

### **Objectives**

The workshop will provide policy-makers, social partners, experts and other actors with an opportunity to exchange on key challenges and priority actions in the Western Balkans for tackling informality from a holistic perspective. Inspired by the work of the European Platform Tackling Undeclared Work, the conference will also encourage an open discussion on ways to establish a strong base for exchange of good practices and mutual learning among peer institutions and key stakeholders in the Western Balkans. Finally, a proposal to establish a structured regional network that will promote knowledge sharing as well as mutual and joint learning and action will be tabled with a view to ensuring regional commitment to continued regional cooperation on tackling undeclared work in the Western Balkans.
